Article II. Election Districts.

Sec. 7-6. Purpose.

The purposes of this article are:

- (a) To establish seven election districts within the County as the major electoral subdivisions on which to base representation of the governing body.
- (b) To name such districts.
- (c) To establish by narrative and map delineation readily recognizable boundaries for such districts.
- (d) To apportion representation on the Board of Supervisors based on election districts.
- (e) To provide for the retention of the existing six magisterial districts as County geographic subdivisions to be perpetuated in County land and property records. (3-8-79, §1-1.)

Sec. 7-7. Short title.

This article is assigned the short title of and may be cited as the “Election District Ordinance of Campbell County, Virginia.” (3-8-79, §1-2.)

Sec. 7-8. Created.

There are hereby created and established seven election districts within the County. (3-8-79, §2-1.)

Sec. 7-9. Names.

The seven election districts created and established in this article are specifically designated as follows, with accompanying population figures derived from the 2010 United States Decennial Census set forth opposite each district:

Sec. 7-10. Boundaries.

The boundaries of the seven county election districts created and established in this article shall be set forth below in narrative description and as delineated on a County map maintained for such purpose, as such map may be revised from time to time, which map is incorporated herein by reference; except, that in any variance between the narrative description and map depiction, the narrative form shall control.

Number I. Timberlake Election District.

Beginning at the intersection of the Campbell County/Bedford County line and Buffalo Creek; thence with the centerline of the bed of Buffalo Creek as it meanders in a east then southeast then easterly direction to its intersection with Town Fork Road; thence crossing Town Fork Road with the centerline of the bed of an unnamed creek in a northerly direction to its intersection with Tanglewood Drive; thence with the centerline of Tanglewood Drive in a northwestern then western direction to its intersection with Town Fork Road; thence with the intersection of Town Fork Road a northerly direction to its intersection with Alum Springs Road; thence with the centerline of Alum Springs Road in an easterly direction to its intersection with Fowler Street; thence continuing with the centerline of Alum Springs Road in a northeasterly direction to its intersection with New London Drive; thence with the centerline of New London Drive in a northwesterly direction to its intersection with Lynchburg Highway; thence with the centerline of the said Lynchburg Highway in a northeasterly direction to its intersection with the Lynchburg Highway ramp; thence with the Lynchburg Highway ramp which becomes Timberlake Road and with the centerline of Timberlake Road in a northeasterly direction to its intersection with the Lynchburg City Limit; thence with the Lynchburg City Limit in a westerly direction to the Campbell County/Bedford County line; thence with the Campbell County/Bedford County line in a more less southwesterly direction to the point and place of beginning.

Number II. Sunburst Election District.

Beginning at the intersection of Campbell County/Bedford County line and Buffalo Creek; thence with the Campbell County/Bedford County line in a southwesterly direction to its intersection with Austin Mill Road; thence with the centerline of Austin Mill Road in an easterly direction to its intersection with Buffalo Mill Road; thence with the centerline of Buffalo Mill Road in a southerly direction; thence southeasterly to its intersection with Buffalo Creek; thence a line with the eastern bank of Buffalo Creek until it meanders to the west; thence with a line in a southeasterly direction back to the centerline of Buffalo Mill Road; thence with the centerline of Buffalo Mill Road in a southeasterly direction to its intersection with Leesville Road; thence with the centerline of Leesville Road in a southerly direction to its intersection with Colonial Highway; thence with the centerline of Colonial Highway in an easterly direction to its intersection with the Appalachian Power Company high voltage transmission line; thence with the centerline of the right-of-way of the said high voltage power line in a northerly direction to its intersection with Yellow Branch; thence with the centerline of the bed of Yellow Branch in a northwesterly direction to its intersection with Flat Creek; thence with the centerline of the bed of Flat Creek in an eastern then northern direction as it meanders to its intersection with Lynbrook Road; thence in a straight line northwest to the intersection of Waterlick Road; thence with the centerline of Waterlick Road in a northerly direction to its intersection with Leesville Road; thence with the centerline of Leesville Road in a northeasterly direction to its intersection with Sherbrooke Drive; thence with the centerline of Sherbrooke Drive in a northwesterly direction to its intersection with Lighthouse Drive; thence with the centerline of Lighthouse Drive to the Lynchburg City Limit; thence with the Lynchburg City Limit in a westerly direction; thence northerly direction; thence westerly direction again to its intersection with Timberlake Road; thence with the centerline of Timberlake Road in a southerly direction to its intersection with the Lynchburg Highway ramp; thence with the centerline of Lynchburg Highway in a westerly direction to its intersection with New London Drive; thence with the centerline of New London Drive in a southeasterly direction to its intersection with Alum Springs Road; thence in a southwesterly direction with the centerline of Alum Springs Road to its intersection with Fowler Street; thence continuing with the centerline of Alum Springs road to its intersection with Town Fork Road; thence in a southerly direction with the centerline of Town Fork Road to its intersection with Tanglewood Drive; thence with the centerline of Tanglewood Drive in an easterly direction to its intersection with an unnamed creek; thence with the centerline of the bed of the unnamed creek as it meanders to its confluence with Buffalo Creek near Town Fork Road; thence with the centerline of the bed of Buffalo Creek it meanders in a west then northwest direction to the Bedford County/Campbell County line and to the point and place of beginning.

Number III. Altavista Election District.

Beginning at the intersection of Austin Mill Road and the Campbell County/Bedford County line; thence with the Campbell County/Bedford County line in a southwesterly direction

to the centerline of the bed of the Roanoke/Staunton River, now inundated by the waters of Leesville Reservoir; thence with the centerline of the old Roanoke/Staunton River bed, in the waters of Leesville Reservoir, in an easterly direction, then northerly direction to Leesville Dam; thence with the centerline of the bed of the Roanoke/Staunton River as it meanders to its intersection with Hills Creek just south of the Southern Railway right-of-way; thence with the centerline of the bed of Hills Creek as it meanders in a northeasterly direction to its intersection with Gladys Road; thence with the centerline of Gladys Road in a northwesterly direction to its intersection with Lambs Church Road; thence with the centerline of Lambs Church Road in a northerly direction to its intersection with a farm road near Lambs United Methodist Church; thence with the centerline of said farm road in a northerly direction to its intersection with Marysville Road; thence with the centerline of Marysville Road in a northwesterly direction to its intersection with Wards Road; thence with the centerline of Wards Road in a northerly direction to its intersection with Dearborn Road; thence with the centerline of Dearborn Road in a westerly direction to its intersection with Blackwater Road; thence with the centerline of Blackwater Road in a northerly direction to its intersection with Masons Mill Road; thence with the centerline of Masons Mill Road in a northerly direction to its intersection with Colonial Highway; thence with the centerline of Colonial Highway in a westerly direction to its intersection with Leesville Road; thence with the centerline of Leesville Road in a northerly direction to its intersection with Buffalo Mill Road; thence with the centerline of Buffalo Mill Road in a northwesterly direction to its intersection with Austin Mill Road; thence with the centerline of Austin Mill Road in a westerly direction to the Campbell County/Bedford County line and the point and place of beginning.

Number IV. Rustburg Election District.

Beginning at the intersection of Wards Road and Colonial Highway; thence with the centerline of Wards Road in a southerly direction to its intersection with Brentwood Lane; thence with the centerline of Brentwood Lane in an easterly direction to its intersection with an unnamed creek; thence with the centerline of the bed of the unnamed creek in a southeasterly direction to its intersection with Gough Road; thence with the centerline of Gough Road in a southerly direction to its intersection with Browns Mill Road; thence with the centerline of Browns Mill Road in an easterly direction to its intersection with Seneca Creek; thence with the centerline of the bed of Seneca Creek as it meanders in a southerly direction to its intersection with East Ferry Road; thence with the centerline of East Ferry Road in a northerly direction to its intersection with Elliott Road; thence with the centerline of Elliott Road in an easterly direction to its intersection with East Little Seneca Creek; thence in a straight line to the intersection of Winfall Road and Brookneal Highway; thence with the centerline of Winfall Road in an easterly direction to its intersection with Red House Road; thence with the centerline of Red House Road in an easterly direction to its intersection with Bear Creek Road; thence with the centerline of Bear Creek Road in a northerly direction to its intersection with Bear Creek; thence with a farm road in an easterly then northerly direction to its intersection with Red Oak School Road; thence with the centerline of Red Oak School Road in an easterly then northerly direction to its intersection with Manley Branch Road; thence with the centerline of Manley Branch Road in an easterly direction to its intersection with Spring Mill Road; thence with the centerline of Spring Mill Road in a southeasterly direction to its intersection with New Chapel Road; thence with the centerline of New Chapel Road to the Campbell County/Appomattox County line; thence continuing in a northerly direction with the Campbell County /Appomattox County line to its intersection with New Chapel Road; thence with the

centerline of New Chapel Road in a northerly then northwesterly direction to its intersection with Plum Branch Road; thence with the centerline of Plum Branch Road in a northwesterly direction to its intersection with Wheeler Road; thence with the centerline of Wheeler Road in a southwesterly direction to its intersection with Popular Springs Branch; thence with the centerline of Popular Springs Branch in a northwesterly direction to its intersection with Morton Creek Road; thence with the centerline of Morton Creek Road in a westerly direction to its intersection with Village Highway; thence with the centerline of Village Highway in a northerly direction to its intersection with Oxford Furnace Road; thence with the centerline of Oxford Furnace Road in a northerly direction to its intersection with Holiday Lane; thence with the centerline of Holiday Lane in an southwesterly direction to its intersection with Smoky Hollow Road; thence with the centerline of Smoky Hollow Road to Poor House Road; thence from the centerline of Poor House Road to its intersection with Carters Creek; thence with the centerline of the bed of Carters Creek as it meanders in a northwesterly direction to its intersection with Beaver Creek; thence with the centerline of the bed of Beaver Creek as it meanders in a southwesterly direction to its intersection with Campbell Highway; thence with the centerline of Campbell Highway south to its intersection with Beaver Creek Crossing road; thence with the centerline of Beaver Creek Crossing road to its intersection with the Norfolk Southern Railway right-of-way; thence with the Norfolk Southern Railway right-of-way to its intersection with Suburban Road; thence with the centerline of Suburban Road in a westerly direction to its intersection with the centerline of English Tavern Road; thence with the centerline of English Tavern Road in a southerly direction to its intersection with Wards Road; thence with the centerline of Wards Road in a southerly direction to its intersection with Colonial Highway at the point and place of beginning.

Number V. Spring Hill Election District.

Beginning at the intersection of Wards Road and Dearborn Road, thence with the centerline of Wards Road in a southerly direction to the intersection with Marysville Road; thence with the centerline of Marysville Road in a southeasterly direction to its intersection with East Ferry Road; thence with the centerline of East Ferry Road in a northeasterly direction to its intersection with Seneca Creek; thence with the centerline of the bed of Seneca Creek as it meanders in a northerly then westerly then northerly direction its intersection with Brown’s Mill Road; thence with the centerline of Brown’s Mill Road in a westerly direction to its intersection Gough Road; thence with the centerline of Gough Road in a northerly direction to its intersection with an unnamed creek; thence with the centerline of the bed of the unnamed creek in a northwesterly direction to its intersection with Brentwood Lane; thence with the centerline of Brentwood Lane in a westerly direction to its intersection with Wards Road; thence with the centerline of Wards Road in a northerly direction to its intersection with English Tavern Road; thence with the centerline of English Tavern Road in a northerly direction to its intersection with Flat Creek; thence with the centerline of the bed of Flat Creek in an easterly direction to its intersection with the right-of-way of the Appalachian Power Company high voltage transmission line; thence in a northerly direction following the right-of-way of the Appalachian Power Company high voltage transmission line to its intersection with Candler’s Mountain Road; thence with the centerline of Candler’s Mountain Road in an easterly direction to its intersection with Camp Hydaway Road; thence with the centerline of Camp Hydaway Road in a northerly direction to its intersection with Old Rustburg Road; thence with the centerline of Old Rustburg Road in a northerly direction to its intersection with a branch of Little Opossum Creek; thence with the centerline of the bed of Little Opossum Creek as it meanders in a

northeasterly direction to its intersection with the Lynchburg City Limit; thence with the Lynchburg City Limit in a northwesterly, southwesterly then westerly direction to its intersection with Lighthouse Drive; thence with the centerline of Lighthouse Drive in a southerly direction to its intersection with Sherbrook Drive; thence with the centerline of Sherbrook Drive continuing in a southerly direction to its intersection with Leesville Road; thence with the centerline of Leesville Road in a southwesterly direction to its intersection with Waterlick Road; thence with the centerline of Waterlick Road in a southerly direction to its intersection with Flat Creek; thence with the centerline of the bed of Flat Creek as it meanders in a southerly direction to its intersection with Yellow Branch; thence with the centerline of the bed of Yellow Branch as it meanders in an easterly direction to the Appalachian Power Company high voltage transmission line; thence with the right-of-way of the Appalachian Power Company high voltage transmission line in a southwesterly direction to its intersection with Crown Lane; thence with the centerline of Crown Lane in a southerly direction to the intersection with Mason's Mill Road; thence with the centerline of Mason's Mill Road to its intersection with Blackwater Road; thence with the centerline of Blackwater Road in a southerly direction to its intersection with Dearborn Road; thence with the centerline of Dearborn Road in a southerly then easterly direction to its intersection with Wards Road and the point and place of beginning.

Number VI. Concord Election District.

Beginning at the intersection of the Campbell County/Appomattox County line and New Chapel Road; thence in a northerly direction with the Campbell/Appomattox County line to the James River; thence with the centerline of the bed of the James River in a westerly direction to the intersection of the City Limit of the City of Lynchburg; thence with the centerline of the City Limit of the City of Lynchburg in a southwesterly direction and as it follows Little Opossum Creek to the intersection of the Norfolk Southern Railway right-of-way; thence with the centerline of the bed of Little Opossum Creek in a southwesterly direction to its intersection with Old Rustburg Road; thence with the centerline of Old Rustburg Road in a southwesterly direction to its intersection with Camp Hydaway Road; thence with the centerline of Camp Hydaway Road in a southwesterly direction to its with Candler's Mountain Road; thence with the centerline of Candler's Mountain Road in a westerly direction to its intersection with the Appalachian Power Company high voltage transmission line; thence with the centerline of the right-of-way of the Appalachian Power Company high voltage transmission line in a southwesterly direction to its intersection with Flat Creek; thence with the centerline of the bed of Flat Creek in a southwesterly direction to its intersection with English Tavern Road; thence with the centerline of English Tavern Road in a southerly direction to its intersection with Suburban Road; thence with the centerline of Suburban Road in an easterly direction to its intersection with Norfolk Southern Railway right-of-way; thence in a northerly direction with the centerline of the right-of-way of the Norfolk Southern Railway to its intersection with Beaver Creek Crossing Road; thence with the centerline of Beaver Creek Crossing Road to its intersection with Campbell Highway; thence with the centerline of Campbell Highway north to its intersection with Beaver Creek; thence with the centerline of the bed of Beaver Creek as it meanders in a northeasterly direction to its intersection with Carters Creek; thence with the centerline of the bed of Carters Creek as it meanders in an easterly direction to its intersection with Poor House Road; thence with the centerline of Poor House Road in an easterly direction to its intersection with Smokey Hollow Road; thence with the centerline of Smokey Hollow

Road to its intersection with Holiday Lane; thence with the centerline of Holiday Lane in a northeasterly direction to its intersection with Oxford Furnace Road; thence with the centerline of Oxford Furnace Road in a southerly direction to its intersection with Village Highway; thence with the centerline of Village Highway in a southerly direction to its intersection with Morton Creek Road; thence with the centerline of Morton Creek Road in an easterly direction to its intersection with Popular Springs Branch; thence with the centerline of the bed of Popular Springs Branch as it meanders in a southerly direction to its intersection with Wheeler Road; thence with the centerline of Wheeler Road in a northeasterly direction to its intersection with Plum Branch Road; thence with the centerline of Plum Branch Road to its intersection with New Chapel Road; thence with the centerline of New Chapel Road in an easterly direction to the Campbell County/Appomattox County line and the point and place of beginning.

Number VII. Brookneal Election District.

Beginning at the centerline of the bed of the Roanoke/Staunton River and the Campbell County/Charlotte County line; thence running north with the Campbell County/Charlotte County line to the Campbell County/Appomattox County line; thence with the Campbell County/Appomattox County line in a westerly thence northerly direction to its intersection with County Line Road; thence with the centerline of County Line Road to Bent Creek Road and with the centerline of Bent Creek Road to its intersection with New Chapel and Spring Mill Roads, all along the Campbell County/Appomattox County line; thence in a northwesterly direction with the centerline of Spring Mill Road to its intersection with Manley Branch Road; thence with the intersection of Manley Branch Road in a southerly direction to its intersection with Red Oak School Road; thence with the centerline of Red Oak School Road in a westerly direction to its intersection with a farm road a short distance south of Bunny Hop Lane; thence with the centerline of said farm road to its intersection with Bear Creek Road; thence with the centerline of Bear Creek Road in a southerly direction to its intersection with Red House Road; thence with the centerline of Red House Road in a northwesterly direction to its intersection with Winfall Road; thence with the centerline of Winfall Road in a westerly direction to its intersection with Brookneal Highway and the tracks of the Norfolk Southern Railway right-of-way; thence in a straight line in a westerly direction to its intersection with Elliott Road; thence with the centerline of Elliott Road in a westerly direction to its intersection with East Ferry Road; thence with the centerline of East Ferry Road in a southerly direction to its intersection with Marysville Road; thence with the centerline of Marysville Road in a northwesterly direction to its intersection with a farm road a short distance south of Andrews Lane; thence with the centerline of that farm road to its intersection with Lambs Church Road; thence with the centerline of Lambs Church Road to its intersection with Gladys Road; thence with the centerline of Gladys Road to its intersection with Hills Creek; thence with the centerline of the bed of Hills Creek in an southwesterly direction to its intersection with the Roanoke/Staunton River; thence with the centerline of the bed of the Roanoke/Staunton River as it meanders to the Charlotte County/Campbell County line and point and place of beginning.

Sec. 7-11. Representation.

Commencing with the applicable elections conducted in calendar year 1979 for terms of office beginning on January 1, 1980, one member of the Board of Supervisors shall be elected from each of the seven (7) County election districts created and established in this article.(3-8-79, §3-1.)

Sec. 7-12. Repealed.

[Former §7-12, enacted on March 8, 1979, effective through January 1, 1980, was an interim ordinance to ensure continuity during the transition from six magisterial districts to seven election districts created and established in this article, and was formally repealed by the 1986 Act.]

Sec. 7-13. Magisterial district retention.

All of the six magisterial districts established, bounded and named by the County ordinance adopted June 7, 1971, shall continue in existence as named and described in such ordinance, as amended, except as partially repealed in this article, for the sole purpose of locating property in deed descriptions and county land and property records. Sec. 7-15. Short title.

Sec. 7-16.1. Central Absentee Voter Precinct.

There is hereby established in accordance with the provisions of VA. CODE ANN. §24.2-712 (Cum. Supp. 2021) a Central Virginia Absentee Voter Precinct in the Campbell County Historic Clerk’s Office located on Old Courthouse Square, Village Highway, Rustburg, Virginia. The purpose of the central absentee voter precinct shall be to receive, count and record absentee ballots cast within the County in all elections.

The provisions of VA. CODE ANN. §24.2-712 (Cum. Supp. 2021) as the same may be amended from time to time shall govern the conduct of elections at the Central Absentee Voter Precinct established by this section.

Sec. 7-18. Notification of voters.

Notice of any adopted change in any election district, town, precinct, or polling place other than in the location of the office of the general registrar shall be mailed by the General Registrar of Campbell County to all registered voters whose election district, town, precinct, or polling place is changed at least 15 days prior to the next general, special, or primary election in which the voters will be voting in the changed election district, town, precinct, or polling place. Notice of a change in the location of the office of the general registrar shall be given by posting on the official website of the County, by posting at not less than 10 public places, or by publication once in a newspaper of general circulation in the County within not more than 21 days in advance of the change or within seven days following the change. (4-11-79, §3-1.)
