

Campbell County currently operates nine rural transfer sites at which all County citizens (including the residents of Brookneal and Altavista) may deposit household waste at no charge. Large, bulky items, such as appliances, mattresses and furniture, tires, televisions, and brush must be brought to either the Campbell County Landfill Center or the Regional Landfill (361 Livestock Road) for disposal.

Gated Transfer Sites are open 6:30 a.m. until 9:00 p.m. at the following locations:

- **Altavista;** 2352 Dearing Ford Road, Altavista, VA 24517
- **Campbell;** 361 Livestock Road, Rustburg, VA 24588
- **Concord;** 7525 Village Highway, Concord, VA 24538
- **Evington;** 371 Evington Road, Evington, VA 24550
- **Three Forks;** 4150 Red House Road, Rustburg, VA 24588

The following Transfer Sites are open to the public 24 hours a day:

- **Brookneal;** 97 Price Avenue, Brookneal, VA 24528
- **Falling River;** 11351 Red House Road, Brookneal, VA 24528
- **Gladys;** 90 School Road, Gladys, VA 24554
- **Hodges;** 4873 Marysville Road, Altavista, VA 24517

Excerpt from County Code: Chapter 12 Load Size, Tires, and Brush and Yard Waste

Load Size. Residential debris hauled in any vehicle including commercial or employer-owned vehicles will be limited to the equivalent of a pickup truck bed of approximately 60 cubic feet per day. Any larger loads must be taken to the Region 2000 landfill.

Tires. County residents may dispose of eight (8) tires, in loads of up to four (4) tires at a time, at the Livestock Road Transfer Site only, at no charge within the same calendar year. The Towns of Altavista and Brookneal may bring tires from their town maintenance shops only to the Livestock Road Transfer Site. All others must be taken to the Region 2000 Services Authority Landfill.

Brush and Yard Waste. County residents may dispose of an unlimited amount of brush and yard waste collected from their residences at the Livestock Road Transfer Site only. All commercial haulers of brush and yard waste must take their loads to the Region 2000 Services Authority Landfill unless they have negotiated a separate contractual arrangement with the County Director of Public Works.

Additional restrictions may be found in the Campbell County Code, Chapter 12 (Garbage, Refuse, and Weeds).

**Please note: The Regional Landfill is located at 361 Livestock Road in Rustburg (formerly the Campbell County Landfill site), adjacent to the Campbell County Livestock Market.*

For your convenience, refuse and recycling bins are located at 427 Livestock Road in Rustburg, across from the Livestock Market.

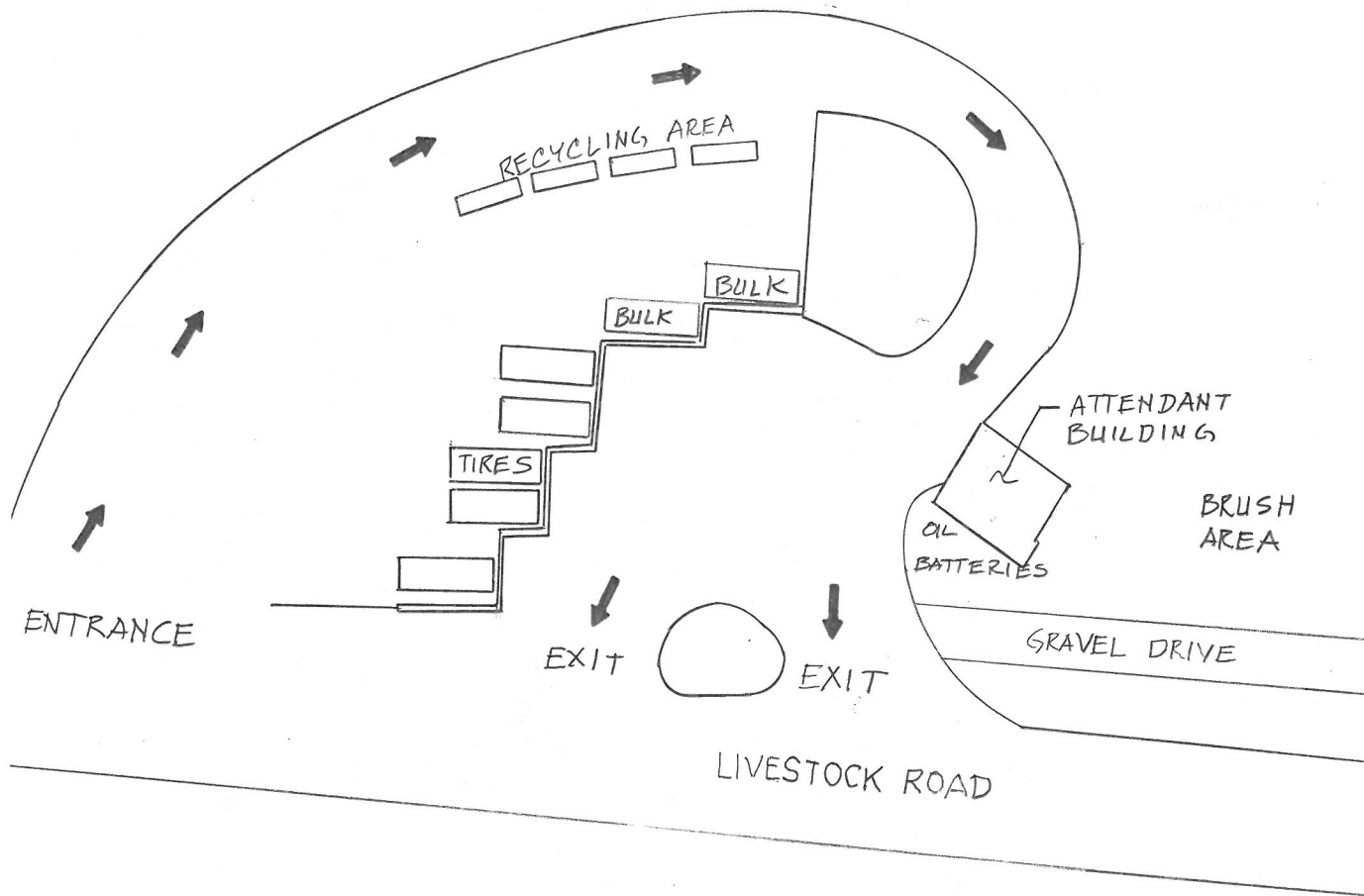

Campbell County Residential Customers

Effective July 9, 2012, the Region 2000 Services Authority will move landfill operations from the Concord Turnpike facility to Campbell County's Livestock Road facility (located at 361 Livestock Road, across from Foster Fuels on Route 29).

As there will be increased traffic in the vicinity of the Landfill Convenience Center, citizens are asked to use caution when entering Livestock Road; it is anticipated that the busiest times will be from 7:00 a.m. to 9:00 a.m. and 3:00 p.m. to 5:00 p.m.

Please follow the indicated traffic pattern (as seen on the back-page diagram) and check with the site attendant for directions on where to dispose of tires, brush and white goods (appliances).

This center will operate from 6:30 a.m. to 9:00 p.m., seven days of the week. In addition to household trash, this drop-off center will accept clean brush, tires, appliances, small bulky items, oil, batteries and other recyclables. The Landfill Center Attendant will provide directions on-site as to where to dispose of these materials. Waste acceptance policies can be found in Chapter 12 of the Campbell County Code.

Items permitted at the center include:

- Bagged household waste
- Construction and demolition waste (from residential improvement projects only – no shingles are allowed at any time).
- Latex paint – dried with saw dust or kitty litter.

Items not accepted at the center:

- Regulated hazardous materials
- Pesticide containers not cleaned, crushed and opened
- Drums, not emptied, cleaned and opened
- Gas tanks and cylinders
- PCB or Dioxin containing solid waste
- Fluorescent bulbs
- Shingles*
- Dead animals*

Items Accepted for Recycling:

- Waste Oil
- Batteries
- Tires
- White goods (appliances)
- Mixed paper
- Newspaper
- Aluminum
- Aluminum cans; Bi-metal cans
- Corrugated cardboard
- Brush and leaves, not bagged

**Shingles and dead animals will not be allowed at any of the drop-off centers, but will need to be taken to the regional landfill on Livestock Road at the standard tipping fee.*
